# Sharing branch closure feedback

We're now nearing the closure of the Belgravia branch of Barclays. Our first booklet explained why the branch is closing, and gave information on other banking services that we hope will be convenient for you.

We do understand that the decision to close a branch affects different communities in different ways, so we've spoken to people in your community to listen to their concerns. We wanted to find out how your community, and particular groups within it, could be affected when the branch closes, and what we could do to help people through the transition from using the branch with alternative ways to carry out their banking requirements.

There are still many ways to do your banking, including in person at another nearby branch, at your local Post Office or over the phone on **0345** 7 **345** 3**45**<sup>2</sup>. You can also go online to barclays.co.uk/waystobank to learn about your other options. Read more about this on page 6.

# We asked each of the groups 3 questions – here's what they said:

In your opinion, what's the biggest effect that this branch closing will have on your local community?

## You said to us:

There are some concerns that the branch closure may have an impact on the community and concerns were also raised about the loss of the cash machine.

## We'd like to say:

We understand the concerns about the closure – and we'd like to reassure everyone that, before deciding to close, we looked very carefully at how the branch is used. We've seen a general fall in customers coming to this branch, and many customers already use nearby branches and online or telephone banking.

To help maintain a community focus, we are explaining to customers how their everyday banking can be done at the Post Office in Knightsbridge – it's open Monday, Wednesday, Thursday and Friday between 9am and 5.30pm, Tuesday between 9.30am and 5.30pm, and Saturday between 9am and 12.30pm. We're helping our customers understand which transactions they can do there, and offering them support through this transition.

There are cash machines nearby at two BT kiosks and the Al Rayan Bank – all are free to use.

## What's the biggest effect that this branch closing will have on customers of the branch?

#### You said to us:

Few concerns were raised about the impact the closure may have on customers using the branch, but customers have said they will miss the personal service they receive in their local branch.

## We'd like to say:

For many customers, particularly those who prefer a personal service, the nearest branches are Knightsbridge and Sloane Square. We'd like to reassure the community that the staff who work in the branch are being relocated to nearby branches. This will mean that customers will be able to see familiar faces when they visit these branches after the closure.

We're speaking individually to those customers who are most likely to be affected by the closure, and we're helping them feel more confident with alternative ways to bank if they do not want to travel to a nearby branch. This includes speaking to someone in person through telephone banking.

The nearest branches are in Knightsbridge and Sloane Square. However we understand it's not always convenient to travel, so we've been offering support from our Digital Eagles in our branch, to help customers adapt to new ways of banking and how to bank from home, so they don't need to use a branch as often.

## What alternative ways to bank do you believe would help people adapt to the change?

#### You said to us:

The closure means customers will need help getting used to new banking methods, particularly those who are not confident about banking online or using mobile banking.

## We'd like to say:

We're encouraging customers to do their everyday banking in other ways, including mobile and online banking – and telephone banking for those who prefer to speak to someone.

We've arranged Tea and Teach sessions as well as face-to-face appointments at the branch to show customers other ways to bank, including how they can set up regular payments, pay in cheques and how to use Pingit or Barclays Mobile Banking on their mobile phones. We've also shown customers how to order cards and PINs, and we're helping everyone remain vigilant against fraud. Support is available through our telephone and online services, too.

## Other things that could help

Banking at the Post Office is available to both personal and business customers – where they can withdraw and pay in cash, and check their balances using a debit card and PIN. Customers can also pay in cash using a pre-printed paying-in slip.

Cheques can be deposited at the Post Office – customers will need a pre-printed paying-in slip, along with a cheque deposit envelope.

- Cheque deposit envelopes we have supplies of envelopes in the Belgravia branch, so please visit us before it closes to pick some up. Otherwise, call us on  $0800\ 169\ 3091^*$  and we'll pop some in the post
- Pre-printed paying-in slips are at the back of a Barclays cheque book. They can also be ordered at any branch or by calling  $0800\ 169\ 3091^*$

Please allow an extra 2 days for cheques or cash deposited using a pre-printed paying-in slip to reach your Barclays accounts.

## Telephone Banking

Available 24 hours a day, seven days a week. You can hear your balance, check transactions, pay bills and transfer money. You can speak to an adviser about your banking needs too. To register, just call 0345 734 5345<sup>2</sup>.

## **Barclays Pingit**

Sending money is secure and instant with no need to share bank account details. You're automatically protected in the event of fraud as long as you've used the services correctly. The Barclays Pingit app is free to download from your app store<sup>3</sup>.

## The Post Office

All customers can pay cash in, withdraw cash and check balances using their Barclays debit card and PIN at thousands of Post Office branches across the country.

All customers can also pay cash and cheques into a Barclays account using a personalised paying-in slip. For cheques, you'll also need a cheque deposit envelope. You will need to allow two extra working days for cheques to reach your Barclays accounts.

Transaction charges for Business transactions will apply.

## Link cash machines

Withdraw cash free of charge, check your balance and request a receipt at any cash machine displaying the Link sign. You can also print off a mini statement at Barclays cash machines.
