These Final Terms are supplemental to and should be read in conjunction with the GSSP Base Prospectus 6 dated 14 June 2013 (the "Base Prospectus"), as supplemented on 10 October 2013 and 23 December 2013, which constitutes a base prospectus for the purpose of the Prospectus Directive. Full information on the Issuer and the offer of the Warrants is only available on the basis of the combination of these Final Terms and the Base Prospectus. A summary of the individual issue of the Warrants is annexed to these Final Terms.
