In addition, certain other factors beyond the Barclays Bank Group's control, including escalation of terrorism or global conflicts, natural disasters, pandemics and similar events, although not detailed below, could have a similar impact on the Barclays Bank Group.

- Material existing and emerging risks potentially impacting more than one principal risk: In addition to material and emerging risks impacting the principal risks set out below, there are also material existing and emerging risks that potentially impact more than one of these principal risks. Climate risk: Climate risk is the impact on financial and operational risks arising from climate change through physical risks,
risks associated with transitioning to a lower carbon economy and connected risks arising as a result of second order impacts of
these two drivers on portfolios.

The Securities will be issued in pounds sterling ("GBP") (the "Issue Currency") and settled in the same currency (the "Settlement Currency"). The Securities are tradable in nominal and the specified denomination per Security is GBP 1. The issue size is GBP 3,250,000. The issue price is 100% of the Specified Denomination.
