The Securities are tradable in nominal and the specified denomination per Security is EUR 1,000. The issue size is EUR 60,000,000. The issue price is 99.50% of the Specified Denomination.

The issue date is 26 April 2021 (the "Issue Date"). Subject to early termination, the Securities are scheduled to redeem on 26 April 2023 (the "Scheduled Settlement Date").

B - Automatic Settlement (Autocall)

C - Final Settlement

If the Securities have not otherwise redeemed, each Security will be redeemed on the Scheduled Settlement Date by payment of the Final Cash Settlement Amount.
